The Bordentown Youth Wrestling Club (BYWC) program is open to all boys and girls in grades K-8

FEES: \$120 per child; fees include uniform requirement and league insurance. A \$50 singlet security deposit is required.

PRACTICE TIMES: 6:30PM – 8:30PM three days per week (usually Monday, Tuesday & Thursday evenings)

PROGRAM: Program runs beginning of November through March. A more definitive schedule will be established when we receive our league schedule

PARENT PARTICIPATION: *We do ask that parents and wrestlers be active participants in our team fundraisers. Fundraising is necessary in order to cover expenses that are required for our organization to exist (i.e. Grapevine fees, security, refs, insurance, etc.) In addition, all parents will be expected to participate in our home meets by donating food items, manning the concession stand and set up and clean up. A schedule will be created and a parent meeting will be held prior to event.*
